Website Changes – A message from Sue Shotton ICPA Aust Website Manager

October was Cyber Security Month which coincided with some very important security changes made to our ICPA websites. Over the past year ICPA has been the target of some very sophisticated email fraud scams. The scams were an attempt to get treasurers to send funds in payment of false invoices. Contact details were taken from the 'Contacts' page on the ICPA website which had previously been open to all viewers.

Federal Council has taken extra steps to minimise our organisation's exposure to this fraud.

All ICPA websites are now HTTPS with SSL certificates, a lock will appear on the address bar of the site you are visiting which indicates a secure website. To limit these fraud emails, Federal Council has decided that no treasurer's contact information will be displayed on the websites.

Please be assured member's details have not been accessed through the ICPA website and member information remains secure.

FAQ's -

How do I notify State and Federal if a member changes their details? A member can change their own details by logging into the website and updating their details. If a branch treasurer or a member needs to notify their State and Federal Treasurers of their changes this can be done by emailing the Federal Membership Officer (fedmembership@icpa.com.au). This position has been created as the Federal contact who deals with memberships and this email is displayed on the Federal website. In the future, all State pages will have their State Council contact list in a locked down form which you must log in to access. Another quick way to get the email address is to just write nswtreasurer@icpa.com.au for NSW and qldtreasurer@icpa.com.au for Qld. The treasurer email addresses are all the same eg. "State"treasurer@icpa.com.au.

What about my branch page? The Treasurer's contact details are missing. Over the next few months your state webmaster will be working with your branch executive and updating your branch page to display what you want displayed.

The EJ Connellan Award provides an opportunity for individuals living in outback Australia to undertake further study or research that otherwise may not be available to them. The EJ Connellan Award provides financial support in two categories: Junior 16-25 years of age and Senior 26 years of age and above. - **Rural and Regional Enterprise Scholarships (STEM Scholarships)**

The Rural and Regional Enterprise Scholarships will be commencing in 2018 and will support 1200 regional and remote students to undertake STEM (Science, Technology, Engineering and Mathematics) studies. The scholarships will be for vocational education, undergraduate and postgraduate students (Certificate IV to PhD). The application period will be from late November 2017 to early January 2018. The Department of Education and Training has advised that the website will be updated soon with information on scholarship application round opening and closing dates, and instructions for applying.

- **Youth Allowance Overview 2018**

The aim is to summarise the lengthy Youth Allowance website. This information relates to rural and remote students planning to study full time and who intend to apply for Youth Allowance. The Youth Allowance Overview 2018 is on the ICPA (Aust) website [here](#). It is a guide only. - **Youth Allowance Changes**

From January 1, 2018, Youth Allowance (YA) changes :- the reduction in the time regional and remote students need to be employed under the self-supporting criteria (Part time work or earnings for rural and remote students) from 18 months to 14 months to qualify for independent Youth Allowance (YA) and ABSTUDY living allowance will come into effect. This criteria will allow students to finish Year 12 and start university after the equivalent of a gap year and at the same time be eligible for independent YA if they have fulfilled all the criteria. The 2016 school leavers will be eligible for this consideration as of January 1, 2018. For more information on the eligibility criteria of dependent and independent Youth Allowance visit [here](#).

AIC Update



The [Department of Human Services](#) are currently posting out the Assistance for Isolated Children (AIC) 'continuing' claims to parents/guardians/carers which will allow families to reapply for their child(ren) for 2018. If parents are expecting one of these questionnaires and haven't received it by the end of October, it is suggested they contact the Department on 132 318 so a replacement may be arranged. Parents are encouraged to complete and return these questionnaires before 1 January 2018. For families intending on claiming AIC for the first time in 2018, forms can be downloaded [here](#)

In Home Care News

Thank you so much to those of you who completed our In Home Care (IHC) Survey several weeks ago. It has helped provide feedback to the developers of the new Home Based Education and Care (HBEC) model which takes over from In Home Care and the Nanny Pilot Program from July 2, 2018. Please be on the lookout for information about this new model from your service providers and we will forward information as we receive it.

As with IHC, the new model will be capped, means-tested and only available where there is no other child care that can be accessed in your area. Please be aware that the new Child Care Subsidy will also apply to HBEC as the Child Care Benefit (CCB) and Child Care Rebate (CCR) was with In Home Care.

The new Child Care Subsidy (CCS) will apply to all child care including that in small towns. Please [click here](#) for information on the new CCS and the very useful CCS estimator which is available [here](#).
